Explain the difference between a positive and a negative correlation coefficient.

Solution

A correlation coefficient is the defining characteristic of a linear regression line, which is used to summarize and model a data set. A positive correlation coefficient means that when the input variable increases, the output variable increases as well. A negative correlation coefficient means that when the input variable increases, the output variable decreases.
